The Farm Share Program provides a discount on the purchase of fresh, local foods by subsidizing the cost of CSA shares or farm stand credits.

All applications will be reviewed in March. Submitting an application does not guarantee you will receive funding. You will receive an update regarding your application status by April. If approved, you will receive instructions on how to pay your cost responsibility and arrange the details of your share. In most cases, you will pay the CSA farm directly.

## Participant Agreement
